Method of preparation

Bake in oven: Bake in a preheated oven at 210°C (hot air) until golden brown, turn once. Thawned product: 8-10 min. Frozen product: 11-13 min.

Fry in pan: Heat oil in a pan and fry until golden brown, turn frequently. Thawned product: 2-4 min, high heat. Frozen product: 4-6 min, high heat.

Deep frying: Fry in a preheated deep fryer at 180°C until golden brown. Thawned product: 2-3 min. Frozen product: 3-4 min. **Airfryer**: Bake in a preheated airfryer at 200°C until golden brown, turn once. Thawned product: 3-5 min. Frozen product: 4-6 min.
